- ➤ It is important to note that the Gibraltar Arc is a geological region, considered one of the most narrowest landforms on Earth.
- Recently, a team of Andalusian scientists, led by the University of Granada (UGR), has been able to reconstruct for the first time what the Gibraltar Arc was like 9 million years ago.
- The researchers have been able to prove that, since then, large blocks of land, with sizes about 300 kilometres long and 150 kilometres wide, have rotated clockwise (in the case of the Baetic System mountain range) and counter-clockwise (in the case of the Rif mountain range, in the north of Morocco).
- The said movements have completely reshaped the Gibraltar Arc, since they have been carried out at a very high speed.

- > It is unfortunate to note that India's trade with Iran is yet to be fully normalised even a year after the lifting of international sanctions on Tehran.
- In fact, Indian exporters are complaining of difficulties faced by them due to some Indian nationalised banks refusing to deal with Iran-related transactions, according to the apex body for exporters in the country, the Federation of Indian Export Organisations (FIEO).

➤ This development is despite the Reserve Bank of India (RBI), in a notification in May 2016, specifying that payment or remittance or reimbursement can be made from or to Iran in any freely convertible currency for imports from Iran and exports to that country.

A note on India- Iran Trade:

- India's trade with Iran in FY'16 was \$9 billion, of which \$6.3 billion were imports from Iran (of which \$4.5 billion was the oil import bill), while India's exports were worth only \$2.7 billion.
- The trade between India and Iran were worth \$16.2 billion in 2011-12 (India's exports of \$2.4 billion and imports from Iran worth \$13.8 billion).
- ➤ It is important to note that, in an effort to boost India-Iran trade, FIEO had in December 2016 asked the RBI to soon allow Iranian banks such as Persia International Bank, Parsian Bank, Bank Pasargad, Bank Mellat and Saman Bank to open branches in India.

It has been suggested that India's fight against leprosy, especially 16 years after being eliminated globally as a public health issue, is far from over.

Important Statistics:

- It is worth pointing out that the World Health Organization (WHO) has asked South-East Asian countries, including India which accounted for 60% per cent of such cases worldwide in 2015, to focus on preventing disabilities in children.
- According to WHO, leprosy affected 2,12,000 people globally in 2015.
- ➤ India alone reported 1,27,326 new cases, accounting for 60% of new cases globally.
- ➤ The other high-burden countries were Brazil and Indonesia.
- ➤ Of the new cases, 8.9% were children and 6.7% presented with visible deformities. The remaining 10,286 new cases (5%) were reported by 92 countries. Thirty countries reported zero new cases.

Significantly, it is important to note that India is among the 22 countries considered as having a "high burden for leprosy" along with high transmission by WHO.

It is important to note that the mode of transmission of leprosy is not known. The most widely held belief is that the disease was transmitted by contact between those with leprosy and healthy persons.

Further, it is important to note that although leprosy affects both sexes, in most parts of the world males are affected more frequently than females, often in the ratio of 2:1, according to WHO's Global Leprosy Report.

- Five years before Rajiv Gandhi was killed in 1991, the U.S. Central Intelligence Agency had prepared a very detailed and thorough "brief" on what would happen if he is assassinated or makes an "abrupt departure" from the Indian political scene.
- A 23-page report, titled "India After Rajiv ..." was put out as early as in March 1986 for comments from other senior CIA officials. The "sanitised" report was declassified recently by the Central Intelligence Agency (CIA). The report, whose complete title is not entirely available as it is part deleted, was prepared on the basis of inputs available to the CIA till January 1986.
- It also dealt with the threats posed to Gandhi's life by various extremist groups at that time and the likely fallout of his murder.

- ➤ Digital payment systems have been in existence for a while, the last few weeks have witnessed an explosive growth in their use. While many welcome the idea of trackable, transparent and frictionless monetary transactions, there are significant risks associated with moving to these systems.
- Vulnerabilities associated with payments systems exist and hence signal the need for caution. Examples follow.
- 1. Compromised applications: The most plausible vulnerability with payment applications is the presence of other applications on a consumer's mobile phone. With some payment wallets, anyone having casual access to a user's mobile phone could be a vulnerability as application PINs are not set up.
- 2. Denial of service: A vulnerability associated with all forms of payment systems is a denial of service attack on the network as whole.
- 3.Man-in-middle vulnerability: In this scenario, a hacker gets access to either the servers on the telecom network, the payment wallet or the bank's networks.
 - While the government has put its weight behind the concept of a cashless economy, it needs to invest sufficiently in securing the network as well as educating the population on how to avoid becoming a victim of fraud. There should be a robust training programme, especially focusing on the old and illiterate who will be affected the most by this transition. Lastly, it must revisit laws and establish a special mechanism to ensure that entities stealing data or preventing legitimate digital transactions are dealt with severely and swiftly in a manner apparent to the public.

What is the NAVIC?

The Indian Regional Navigation Satellite System (IRNSS) with an operational name of NAVIC is an autonomous regional satellite navigation system that is being set up

by India, that will be used to provide accurate real-time positioning and timing services over India and the region extending to 1,500 kilometres (930 mi) around India. The NAVIC system will consist of a constellation of 3 satellites in Geostationary orbit (GEO), 4 satellites in Geosynchronous orbit (GSO), approximately 36,000 kilometres (22,000 mi) altitude above earth surface.

Key Points:

- NavIC, the indigenously built satellite- based positioning system, has developed a technical snag in the atomic clocks on its first satellite.
- ➤ The troubled IRNSS-1A spacecraft was put in space in July 2013 and has an expected life span of 10 years. The seventh navigation satellite, IRNSS-1G, was launched in April 2016.

- > The CRS report merits serious consideration: it has specifically identified a variation in the wheel gauges of two coaches, and found carriages being run beyond their useful life

Problems and wayforward

- ➤ Replacing ageing and unsafe carriages with modern Linke Hofmann Busch coaches is a five-year-old Kakodkar panel recommendation, but supply has not kept pace with requirement. Travel demand has, meanwhile, continued to leap as economic growth both needs and encourages greater mobility.
- Raising the performance of the Indian Railways needs a clear vision for both service and financing, with zero tolerance for accidents. Along with technologies such as ultrasonic flaw detection to keep tracks safe, Railway Minister Suresh Prabhu and his team must look at ways to carry more passengers safely.

- Pradhan Mantri Gramin Awaas Yojana (PMGAY), previously Indira Awaas Yojana (IAY), is a social welfare flagship programme, created by the Indian Government, to provide housing for the rural poor in India. A similar scheme for urban poor was launched in 2015 as Housing for All by 2022.
- In the current financial year, on 20th November, 2016, Hon'ble Prime Minister formally launched Pradhan MantriAwaasYojana (Gramin) PMAY(G), with an original approval for33 lakhs new PMAY Gramin houses, which has now been increased to 44 lakhs.

- ➤ Under PMAY, the cost of unit assistance is to be shared between Central and State Governments in the ratio 60:40 in plain areas and 90:10 for North Eastern and hilly states.
- Identification of beneficiaries eligible for assistance and their prioritisation to be done using information from Socio Economic and Caste Census (SECC) ensuring total transparency and objectivity.

- ➤ No major attack has taken place on U.S. soil in the past eight years. Ultimately, Mr. Trump's insistence on preferential treatment for Christian refugees makes a bogeyman of Muslims, a retrograde action that will exacerbate anti-Americanism worldwide.

Background:

- > The Obama administration imposed sanctions on Russia for its military intervention in Crimea and alleged interference in the U.S. election.
- The U.S. intelligence community has repeatedly slammed Moscow over a number of issues, from "spreading instability" in the world to killing civilians in Syria.

It is important to note that the Central Intelligence Agency has concluded that Russia interfered in the U.S. election to help Mr. Trump win.

Importantly, Mr. Trump believes Russia is no longer the U.S.'s principal global rival. In his world view, China is rising to that stature. To be sure, Russia, with its enormous land and natural resources and strategically important geography and military might, remains a key geopolitical power. But its economy is inherently weak, a shadow of the Soviet economic power.

On the other side, China is an economic powerhouse that wields enormous influence around the world. But China's force-projection capabilities are limited as its seafront remains vulnerable. The U.S. has massive military presence in the Chinese sphere of influence.

It is suggested that if Russia and China come together, that would pose a potential threat to long-term American interests. Mr. Trump would like to use his overtures to Russia to drive a wedge between Moscow and Beijing.

The Three Hurdles:

There are three key problems: political, geopolitical and strategic. Mr. Obama has created enough hurdles for Mr. Trump in dealing with the Russians. Mr. Trump already suffers from a credibility problem after all the allegations of his campaign's links with Russia. Two, Russian foreign policy is historically shaped by its deep insecurity.

Third, today's Russia is not the Russia of 2009 when Mr. Obama became the President and promised a "reset". Russia then was largely confined to its backyard — Eastern Europe, Caucuses and Central Asia. But now Russia has already spread its influence to other regions. It's the dominant player in Syria, a strong ally of Iran (one of the countries targeted by Mr. Trump's Muslim ban order), and a shadow force in Afghanistan where the Americans are fighting an unwinnable war for over 15 years.

- > The average revenue deficit has been eliminated, while the average fiscal deficit was curbed to less than 3% of GSDP.
- ➤ The average debt to GSDP ratio has also fallen
- ➤ Pointing out that the progress cannot be attributed entirely to Fiscal Responsibility Legislations (FRL) adopted in the States, the Survey noted that much of the improvement in financial positions was possible because of exogenous factors, most notably assistance from the Centre in the form of increased revenue transfers, the assumption of state debt, and the introduction of centrally sponsored schemes.

What is RRT?

Redistributive Resource Transfer or RRT to a state (from the Centre) is defined as gross devolution to the state adjusted for the respective state's share in aggregate GDP.

The top 10 recipients are: Sikkim, Arunachal Pradesh, Mizoram, Nagaland, Manipur, Meghalaya, Tripura, Jammu and Kashmir, Himachal Pradesh and Assam.

- > It is important to note that there is an undoubted element of public interest in the manner in which the highest court has engaged itself with the game's administration in recent years.
- Last year, the court declared that running cricket in India is a public function.
- ➤ The Supreme Court accepted most of the recommendations of former Chief Justice of India R.M. Lodha and its sweeping recommendations for reform, and made them binding on the BCCI.
- Following this, the reluctance shown by the BCCI to accept the Lodha panel reforms led to its president Anurag Thakur being held *prima* facie guilty of contempt of court.
- In conclusion, the situation is ripe for a new set of administrators and the next election, which will be overseen by the four-member committee.

- ➤ The Economic Survey emphatically asserts that while there have been shortterm costs to the economy, which would need to be expeditiously addressed, there will be long-term benefits.
- Real GDP growth in the current fiscal, the Survey projects, will see a likely reduction by one quarter to half a percentage point relative to the baseline of about 7% as a result of the demand shock triggered by demonetisation.
- > Devoting a whole chapter to demonetisation, the Survey recommends fast, demand-driven remonetisation, further tax reforms, including bringing land and real estate under the ambit of the Goods and Services Tax, and reducing tax rates and stamp duties.
- ➤ It cautions against tax authorities turning overzealous.
- It flags the risks that Brexit and the U.S. election result pose to the world economic order, and to India's economy.
- > The prospect of "shifts in the direction of isolationism and nativism" could threaten the global market for goods, services and labour.

- The Economic Survey makes a case for replacing India's many direct and indirect subsidies for the poor with one Universal Basic Income (UBI) scheme.
- This idea, being tossed about by academics and policymakers recently, proposes a lumpsum income transfer, calculated according to poverty lines or any other criterion, to be handed over unconditionally, to anyone who qualifies for these grants.
- > It is an appealing thought, but alas, inapplicable in India.
- The virtues and vices of UBI schemes have been debated for decades. Its detractors argue that a scheme that guarantees a basic income could reduce work effort: by as much as 5% per person per year.
- > Supporters argue this cost will be more than offset by lower administrative costs of running large welfare programmes.

It is important to note that a basic income scheme for the poor already exits, the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA), which guarantees 100 workdays per year at minimum wage, to whoever wants it.

Important statistics:

- ➤ MGNREGA costs just 0.3% of GDP, far lower than any UBI scheme; it benefits about 50 million people, mostly women, and has had an enduring knock-on effect in boosting rural incomes and wage rates.
- ➤ It has been suggested that when India can raise tax revenues adding up to a mere 16.5% of GDP, and manages a general government expenditure of about 27% of GDP 57% for France and 38% for the US only by running up a fiscal deficit of close to 7% of GDP, talk of UBI is meaningless.
- Exclusion errors would afflict UBI as well, given India's political economy.

- The Economic Survey 2016-17 tabled in Parliament by the Union Finance Minister Shri Arun Jaitley has advocated the concept of Universal Basic Income (UBI) as an alternative to the various social welfare schemes in an effort to reduce poverty. The survey juxtaposes the benefits and costs of the UBI scheme in the context of the philosophy of the Father of the Nation, Mahatma Gandhi. The Survey states that the Mahatma as astute political observer, would have anxieties about UBI as being just another add-on Government programme, but on balance, he may have given the go-ahead to the UBI.
- The Survey says the UBI, based on the principles of universality, unconditionality and agency, is a conceptually appealing idea but with a number of implementation challenges lying ahead

- especially the risk that it would become an add-on to, rather than a replacement of, current anti-poverty and social programmes, which would make it fiscally unaffordable.
- ➤ Based on a survey on misallocation of resources for the six largest Central Sector and Centrally Sponsored Sub-Schemes (except PDS and fertilizer subsidy) across districts, the Economic Survey points out that the districts where the needs are greatest are precisely the ones where State capacity is the weakest. This suggests that a more efficient way to help the poor would be to provide them resources directly, through a UBI.
- Exploring the principles and prerequisites for successful implementation of UBI, the Survey points out that the two prerequisites for a successful UBI are: (a) functional JAM (Jan Dhan, Aadhar and Mobile) system as it ensures that the cash transfer goes directly into the account of a beneficiary and (b) Centre-State negotiations on cost sharing for the programme.
- ➤ The Survey says that a UBI that reduces poverty to 0.5 percent would cost between 4-5 percent of GDP, assuming that those in the top 25 percent income bracket do not participate. On the other hand, the existing middle class subsidies and food, petroleum and fertilizer subsidies cost about 3 percent of GDP.
- > The Survey concludes that the UBI is a powerful idea whose time even if not ripe for implementation, is ripe for serious discussion.

2. <u>Economic Survey advocates reforms to unleash economic</u> dynamism and social justice

- India needs an evolution in the underlying economic vision across the political spectrum and further reforms are not just a matter of overcoming vested interests that obstruct them.
- ➤ This was stated in the Economic Survey 2016-17 presented in the Parliament today by the Union Finance Minister Shri Arun Jaitley.
- ➤ The Survey lists the some of the challenges that might impede India's progress. These challenges are classified by the Survey as follows: ambivalence about property rights and the private sector, deficiencies in State capacity, especially in delivering essential services and inefficient redistribution.
- ➤ The Survey highlights difficulties in privatizing public enterprises, even for firms where economists have made strong arguments that they belong in the private sector.
- ➤ In this context, the Survey points towards the need to further privatize the Civil Aviation, Banking and Fertilizer sectors.
- ➤ The Survey points out that the capacity of the State in delivering essential services such as health and education is weak due to low capacity, with high levels of corruption, clientelism, rules and red tape.

- ➤ At the level of the states, competitive populism is more in evidence than competitive service delivery, the Survey adds.
- > Constraints to policy making due to strict adherence to rules and abundant caution in bureaucratic decision-making favours status quo, the Survey cautions.
- According to the Survey, redistribution by the government is far from efficient in targeting the poor.
- This is intrinsic to current programs because spending is likely to be greatest in states with better institutions and which will therefore have fewer poor.
- ➤ The Survey notes that over the past two years, the government has made considerable progress toward reducing subsidies, especially related to petroleum products.
- > Technology has been the main instrument for addressing the leakage problem and the pilots for direct benefit transfer in fertilizer represent a very important new direction in this regard, the Survey adds.
- Noting that India has come a long way in terms of economic performance and reforms, Economic Survey 2016-17 says that there is still a journey ahead to achieve dynamism and social justice.
- > Completing this journey will require broader societal shifts in the underlying vision, the Survey adds.

- ➤ With Finance Minister Arun Jaitley deciding against imposing any additional indirect tax burden on them, ahead of the implementation of the Goods & Services Tax (GST) on July 1, 2017, consumers received a major respite.
- Importantly, in his budget speech, the Finance Minister said that "Implementation of GST is likely to bring more taxes both to Central and State Governments because of the widening of the tax net. - > It has been observed that there are three principle goals of the this year's budget.
 - a) It wants to revive the flagging domestic investment, which has threatened to turn turtle.
 - b) It responds to the dire requirement for urgently generating a large number of employment opportunities for the increasingly restive youth.
 - c) It aims at cleansing the economy of black money flows and illegal incomes, thereby sharply squeezing the scope and space for the parallel economy.

It is important to note that following the enactment of the Benami Properties and Illegal Income Acts and demonetisation, the Budget has announced a direct attack on the fountainhead of political corruption by reducing the amount of individual donations to political parties to a paltry Rs. 2,000, as recommended by the Election Commission.

New Initiatives

The Budget also has three firsts to its credit.

- 1) By presenting it on February 1, the Finance Minister has ensured that the rather inefficient practice of 'vote on account' will be avoided and the finance bill will now be approved by the end of the present fiscal year.
- 2) Second, the somewhat spurious and dysfunctional distinction between plan and non-plan expenditure has been done away with, which will permit a clearer distinction between the share of capital and revenue expenditure.
- 3) As its third new initiative, this Budget has done away with the colonial legacy of a separate Railway Budget.

- ➤ In the wake of the demonetization initiative of the Government, it was imperative that Union Finance Minister Arun Jaitley soothed frayed nerves with Budget 2017-18.
- Further, it was equally important that he provided a glimpse of a larger plan to prevent regeneration of black money.
- > It has been observed that he managed to do both to a fair degree, without resorting to blatant populism.

- For corporates, though, there is no road map on lower tax rates.

- ➤ In addition, halving the personal income tax rate from 10% to 5% for those in the lowest tax slab of Rs. 2.5 lakh to Rs. 5 lakh not only puts more money in the hands of this segment, but is also an effective nudge to bring more people into the formal tax net.
- All other taxpayers have been given a benefit of Rs. 12,500 each.
- ➤ Mr. Jaitley said that demonetisation has helped transfer resources from taxevaders to the government.
- > It is important to note that although there may be no big new schemes or dramatic reforms; the big bang in this Budget is the shift from unfettered populism.
- ➤ In conclusion, it is important to note that apart from the dovetailing of the railway budget, the abolition of the distinction between Plan and Non-Plan expenditure and its early presentation, Union Budget 2017-18 marks another break from tradition.

- ➤ There was lot of chatter, including in the latest Economic Survey, about impractical ideas like a universal basic income scheme or using the Reserve Bank of India's "excess capital" to recapitalise state-owned banks the budget has, nevertheless, not gone overboard in the zeal to contain deficits.
- An interesting move is the enabling of the issuance of electoral bonds by political parties. Donors can purchase such bonds from authorised banks and these can be redeemed only in the designated accounts of registered political parties. While helping to retain the anonymity of the donors, it is a welcome initiative for cleansing of electoral funding whether and how it will work on the ground remains to be seen.

The Big Question

Will the latest budget bring back growth and revive the animal spirits of investors? The honest answer is: It is unlikely to do so.

The budget does give a big push for rural development through increased outlays for the Pradhan Mantri Gram Sadak Yojana and the MGNREGA, while aiming at creation of productive assets under the latter. There are also sops for affordable housing, including through the grant of infrastructure status and allowing flexibility in unit area requirements to qualify for benefits.

- In a bid to give a push to Digital Economy and weed-out corruption and black money, the Union Minister for Finance and Corporate Affairs, Shri Arun Jaitley in his Budget Speech said that the Government has decided that no transaction above Rs 3 lakh will be permitted in cash. Accepting a suggestion by Special Investigation Team on Black Money to ban cash transactions above Rs 3 lakhs, the Finance Minister has proposed an amendment to the Income-tax Act in the Finance Bill.
- ➤ Presenting the General Budget 2017-18 in the Parliament, the Finance Minister said that the Government will launch two new Schemes to promote the usage of BHIM App i.e, Referral Bonus Scheme for individuals and a Cashback Scheme for merchants.
- ➤ BHIM App was launched to promote digital transactions and will unleash the power of mobile phones for digital payments and financial inclusion,
- ➤ The Finance Minister Shri Jaitley informed the House that 125 lakh people have adopted the BHIM app so far.
- The Finance Minister Shri Jaitley also announced that Aadhar Pay, a merchant version of Aadhar Enabled Payment System, will be launched shortly.
- This will be specifically beneficial for those who do not have debit cards, mobile wallets and mobile phones. A Mission will be set-up with a target of 2,500 crore digital transactions for 2017-18 through UPI, USSD, Aadhar Pay, IMPS and debit cards. Banks have targeted to introduce additional 10 lakh new PoS terminals by March 2017. They will be encouraged to introduce 20 lakh Aadhar based PoS by September 2017.
- ➤ Highlighting the Government's strategy to clean the system through digital economy, Shri Jaitley said that it has a transformative impact in terms of greater formalisation of the economy and mainstreaming of financial savings into the banking system. This, in turn, is expected to energise private investment in the country through lower cost of credit.
- India is now on the cusp of a massive digital revolution, he added.

- The Finance Minister said that a shift to digital payments has huge benefits for the common man.
- The earlier initiative of the Government to promote financial inclusion and the JAM trinity were important precursors to the current push for digital transactions, the Finance Minister added.
- In a bid to incentivize the digital transactions, the Finance Minister Shri Jaitley proposed that the presumptive income tax for small and medium tax payers whose turn-over is up to Rs 2 crore will be reduced from the present 8% of their turnover which is counted as presumptive income to 6% in respect of turnover which is received by non-cash means. This benefit will be applicable for transactions undertaken in the current year also, he added.
- The Finance Minister also proposed to limit the cash expenditure allowable as deduction, both for revenue as well as capital expenditure, up to Rs 10,000.
- ➤ Similarly, the limit of cash donation which can be received by a Charitable Trust is being reduced from Rs 10,000/- to Rs 2000/-.
- To promote cashless transactions, the Finance Minister in the Budget has proposed to exempt BCD, Excise/CV duty and SAD on miniaturised POS card reader for m-POS, micro ATM standards version 1.5.1, Finger Print Readers/Scanners and Iris Scanners. He also proposed to exempt parts and components for manufacture of such devices, so as to encourage domestic manufacturing of these devices.
- > To strengthen and regulate the digital economy, the Finance Minister has proposed to create a Payments Regulatory Board in the Reserve Bank of India(RBI) by replacing the existing Board for Regulation and Supervision of Payment and Settlement Systems.
- ➤ The Committee on Digital Payments constituted by the Department of Economic Affairs has recommended structural reforms in the payment eco system, including amendments to the Payment and Settlement Systems Act, 2007.
- The Government will undertake a comprehensive review of this Act and bring about appropriate amendments, Finance Minister added.
- To strengthen the digital payment infrastructure and grievance handling mechanisms, the Finance Minister said in his Budget Speech that the focus would be on rural and semi urban areas through Post Offices, Fair Price Shops and Banking Correspondents.
- ➤ He added that steps would be taken to promote and possibly mandate petrol pumps, fertilizer depots, municipalities, Block offices, road transport offices, universities, colleges, hospitals and other institutions to have facilities for digital payments, including BHIM App. A proposal to mandate all the Government receipts through digital means, beyond a prescribed limit, is under consideration. The Government will strengthen the Financial Inclusion Fund to augment resources for taking up these initiatives, the Finance Minister added.
- In his Budget Speech, the Finance Minister informed that increased digital transactions will enable small and micro enterprises to access formal credit. He said that the Government will encourage SIDBI to refinance credit institutions which provide unsecured loans, at reasonable interest rates, to borrowers based on their transaction history.
- ➤ The Finance Minister assured the House that the Government will consider and work with various stakeholders for early implementation of the interim recommendations of the Committee of Chief Ministers on digital transactions.

➤ Shri Jaitley said that the Government is considering the option of amending the Negotiable Instruments Act to ensure that the payees of dishonoured cheques are able to realise the payments.

- It has been suggested that there was no doubt that Finance Minister Arun Jaitley was seeking to address this concern about the lack of transparency and accountability in the funding of political parties when he announced measures in the Union Budget to cleanse the process of making donations toward election expenses of parties.
- > But, there is skepticism about whether his proposals would succeed.
- ➤ It is suggested that the ceiling of Rs. 2,000 on cash donation by any individual to a party, slashed from the existing Rs. 20,000, might inconvenience parties to some extent but is unlikely to stop the disguising of huge, off-the-books cash donations from corporate houses and vested interests as small contributions from ordinary party workers and sympathisers.
- It is feared that the proposal does not disrupt the flow of illicit political donations but only channels it differently, and will not reduce the proportion of cash from unverifiable sources in the total donations received.
- It has been suggested that the Finance Minister should have placed a cap on the amount a party may receive in cash as a donation.
- ➤ It has also been suggested that the proposal to allow donors to purchase electoral bonds from banks against cheque, only clouds the funding process.
- Finally, the Budget also makes it mandatory for political parties to file returns within a time limit, but in the absence of extreme penal provisions compliance is likely to be low.

- ➤ It is important to note that Indian IT firms have been among the top recipients of the 65,000 such visas made available annually via a lottery system, in some years garnering well in excess of 80% of them.
- ➤ In fact, shares in Indian IT majors took a nosedive last week when an unconfirmed draft executive order leaked to U.S. media houses appeared to call for reform of immigration rules for skilled foreign workers that would raise the salary eligibility for such visas to \$130,000
- ➤ Broadly, this visa crackdown in the making raises troubling questions for the U.S. tech sector and the broader economy as well.

Impact:

- > It is important to note that any significant hike in the minimum salary levels for the specialised jobs held by H-1B visa recipients will hit not only Indian IT firms but also the tech titans of Silicon Valley, including Microsoft, Google and Facebook.
- > This will inflict pain on the U.S. economy.
- > Similarly, unless skill-based criteria are used in addition to wage-level restrictions, numerous U.S. firms will struggle to fill mid-level jobs with qualified Americans.

- ➤ The proposed Innovation Fund for Secondary Education is a good initiative and should be so designed as to incentivise teachers and schools to transcend textbook learning.
- ➤ The proposed National Testing Agency for entrance to higher education institutes will help improve standards across the spectrum of higher secondary schools.

In conclusion, the focus now must move to the difficult task of implementation, evaluation and recalibration of measures that will improve the educational experience of all.

- ➤ 1. A Special Scheme for creating employment in leather and footwear industries is proposed to be implemented, on the lines of the scheme in textile and apparel sector.
- ➤ 2. The long standing demand of startups has been accepted and the profit (linked deduction) exemption available to them for 3 years out of 5 years is changed to 3 years out of 7 years. For the purpose of carry forward of losses in respect of startups, the condition of continuous holding of 51% of voting rights has been relaxed subject to the condition that the holding of the original promoter/promoters continues.
- ➤ 3. Further liberalisation of FDI policy is under consideration and the Foreign Investment Promotion Board (FIPB) to be abolished in 2017-18.
- ➤ 4. In order to make MSME companies more viable, income tax for companies with annual turnover uptoRs. 50 crore is reduced to 25%. About 96% of companies will get this benefit of lower taxation. This will make our MSME sector more competitive as compared to large companies.
- > 5. MAT credit is allowed to be carried forward up to a period of 15 years instead of 10 years at present.
- ➤ 6. For creating an eco-system to make India a global hub for electronics manufacturing a provision of Rs. 745 crores in 2017-18 in incentive schemes like M-SIPS and EDF. The incentives and allocation has been exponentially increased following the increase in number of investment proposals.
- > 7. Inverted duty has been rectified in several products in the chemicals & petrochemicals, textiles, metals, renewable energy sectors. Duty changes to improve domestic manufacturing of medical devices, those used for digital transactions and capital goods have also been announced.
- ➤ 8. Infrastructure a key pillar under the Make in India programme has been strengthened with a large budgetary allocation. The total allocation for infrastructure development in 2017-18 stands at Rs. 3,96,135 crores. A specific programme for development of multi-modal logistics parks, together with multi modal transport facilities, to be drawn up and implemented.

- ➤ 9. Tourism is a big employment generator and has a multiplier impact on the economy. Incredible India 2.0 is proposed to be launched to promote tourism and employment. Five Special Tourism Zone, anchored on SPVs in partnership with the States would be set up.
- ➤ 10. Modernisation and upgradation of identified corridor, railway lines of 3,500 kms will be commissioned, 25 stations are expected to be awarded for station redevelopment and 500 stations will be made differently abled friendly by providing lifts and escalators during 2017-18. These provide large opportunities under the Make in India initiative
- ➤ 11. Initiatives in Skill Development provide essential support for the Make in India sectors to thrive. Launch of SANKALP scheme to provide market relevant training to 3.5 crore youth and STRIVE scheme to improve the quality and market relevance of vocational training.
- ➤ 12. A new and restructured Central scheme with a focus on export infrastructure, namely, Trade Infrastructure for Export Scheme (TIES) will be launched in 2017-18.

In what way is it different?

- The U.S. order is to prevent people who the administration feels will possibly indulge in radical terror activities to enter the country, and has more to do with public order and security.
- ➤ India's bill aims to give succour to those persecuted on religious grounds.
- There are many cases of religious persecution and people fleeing to India and it has to be taken into account.

Important Points to Note

- ➤ Under the Citizenship Act of 1955, an applicant for citizenship requires to have resided in India for the last 12 months and for 11 years.
- > The Amendment Bill relaxes this 11-year requirement to six years for persons who are Hindus, Sikhs, Buddhists, Jains, Parsis and Christians fleeing religious persecution from Afghanistan, Pakistan and Bangladesh.

- > The moment the Bill was introduced, there was an uproar that it violated Article 14 of the Constitution, that guaranteed equal treatment under the law to all citizens.
- > The exclusion of people following Islam from this list of relaxed terms is considered a direct violation of that Fundamental Right.

- Recently two ships collided off the coast of Chennai.
- As a consequence, there was destruction caused to a significant part of the Chennai coastline from the oil spill that followed a. This development is both tragic and ironic.

- > A large quantity of oil was released into the sea, affecting marine life and livelihoods of coastal communities. What makes the collision ironic is that it comes at a time when there is steadily declining pollution due to such incidents.
- ➤ It is important to note that ship collisions are less common today because GPS-based navigation systems have made their operation much safer.

Impact

- ➤ A large number of dead turtles and fish were washed ashore
- > Vast amounts of coastal sludge was washed ashore.
- ➤ It could erode the confidence of the international community in India's ability to fulfil its commitments within the UN system to protect marine life and biodiversity.
- ➤ For example, failure to safeguard marine turtle and bird habitats, is a clear violation of the provisions of the Convention on the Conservation of Migratory Species of Wild Animals, and its specific memorandum on the Indian Ocean-Southeast Asian region to which India is a signatory.

The Way Forward

- ➤ It has been suggested that an independent inquiry is vital to determine whether the training and acquisition of equipment to handle such accidents for all agencies passed muster.
- ➤ This disaster also underscores the importance of timely advice from agencies such as the Indian National Centre for Ocean Information Services, which is mandated to forecast the course of an oil spill.

- That the government has taken up the important subject of reforming political funding is a welcome step.
- However, it has been suggested that the proposal set out in the Budget, to let donors buy so-called electoral bonds that can be redeemed only in the account of a political party from banks and donate them to the party of their choice, serves little purpose.
- Under the present norm, parties must maintain a list of all donors who contribute any sum larger than Rs 20,000.
- It has been pointed out that instead of advancing transparency, the bond gives legitimacy to opaque contributions to political parties, thereby, trashing the present norm.

Concluding Remarks

It has been pointed out that parties show only a fraction of their actual spending in the accounts they file.

- > Thus, identifying the source of income for this sliver of their spending is neither here nor there.
- > The starting point of the reform we need is to get a handle on realistic spending by any party.
- ➤ It has been suggested that things might work better if the Election Commission scrapped its impractical spending limit and, instead, made it compulsory for each party and candidate to reveal spending at each level, starting from the polling booth.
- These numbers should be open to challenge by rivals, the media and watchdog bodies.
- Finally, the EC can finalise actual spending, and ask parties to reveal from whom all they received this money.
- This might still leave some political funding unaccounted, but would still mark a huge improvement over the current state of affairs.

- ➤ The Union Budget for 2017-18 clearly highlights the Centre's resolve to promote the digital economy by reducing cash transactions, bringing more economic activity into the formal sector and curbing corruption.
- ➤ But for Digital India to become a reality, it is necessary to first focus on the basics: access to reliable, stable and high-speed internet services all over India.
- ➤ The stepped up funding for expansion of BharatNet a project to connect all 2.5 lakh gram panchayats to a high-speed fibre optic network is welcome.
- ➤ With the Centre planning its 'DigiGaon' village initiative to provide telemedicine, education and skills through digital technology to most of the villages, funding for BharatNet could have been stepped up further, especially since there is a proven link between increase in broadband connectivity and higher GDP.

Measures taken to popularize digital payment

- Measures have also been announced to popularise digital payment modes launched over the past few months.
- > These include a promotional scheme to increase usage of BHIM, an app developed by the National Payments Corporation of India.
- ➤ The two schemes a referral bonus scheme for individuals and a cashback scheme for merchants may help bring new users on to the payment platform.
- Addhaar Pay, a merchant version of Aadhaar Enabled Payment System proposed to be launched soon, may benefit those who do not have debit cards, mobile wallets and mobile phones.

- ➤ Banks have been told to install 10 lakh point-of-sale (PoS) machines by March 2017 as well as 20 lakh Aadhaar-based PoS machines by September 2017.
- ➤ It is important to note that while this will encourage more digital transactions, the Government targets for increasing the number of digital transactions in 2017-18 to 2,500 crore through UPI, USSD, Aadhaar Pay, IMPS and debit cards appears ambitious, given infrastructure constraints and insufficient behavioural change among users.

Concluding Remarks

Nonetheless, the Centre's willingness to consider changes in the regulatory framework for digital payments — among the measures proposed are strengthening of the payment infrastructure and grievance handling mechanisms, and amendments to the Payment and Settlement Systems Act 2007, and Negotiable Instruments Act — is welcome.

- The Minister of Road Transport & Highways and Shipping Shri Nitin Gadkari has lauded the fact that the Union Budget 2017-18 has recognized the need for multi-modal transport planning in the country and has accorded it very high priority. Shri Gadkari said that in order to reduce traffic congestion, bring down pollution and make the overall movement of passengers and goods more efficient and cost effective, the country needs to adopt a holistic and integrated transport planning for the sector as a whole, including roads, railways, waterways and airways.
- The Minister pointed out that in most cities, bus stations, airports, railway stations are situated far apart from each other. If all stations are properly integrated with each other, a lot traffic congestion and pollution can be reduced. Shri Gadkari said that his Ministry is examining the feasibility of setting up multi modal hubs where all modes of transport air, road, rail and waterways wherever possible are within close proximity to each other. Besides this, latest technology for electricity based Mass Rapid Transport like the metrino and hyperloop are being studied and tested.
- ➤ Talking about the road map for the future Shri Gadkari said that the Ministry of Road Transport & Highways hopes to award 15000 km of highways work by the end of March 2017. Per day construction of highways will go up to 30 km by end of March 2017 and the Ministry will strive to achieve its target of building 40 km road per day very soon. Shri Gadkari welcomed the 15 percent rise in budget allocation for the Road Transport & Highways Ministry. He said this will allow the Ministry to take up a lot of new work
- ➤ Talking about the Shipping sector Shri Gadkari said that Sagarmala is all set to be a game changer with its stress on port led development. The programme will create one crore jobs, including 40 lakh direct and 60 lakh indirect ones. Ports are being mechanized and modernized. The draught at ports are being deepened so that bigger ships can come in. In addition to the

above, waterways are being developed in a big way. This includes 111 rivers that are to be developed as National Waterways, and coastal shipping along the country's 7500 km of coastline. Ro-Ro services are being launched to cut down travel time and distance and cruise services are being brought in to carry both goods and passengers. The agenda of the Ministry is to harness the full potential of the maritime sector through its Sagarmala programme.

- ➤ The delegation met various departments in the government of Iran including Food and Drug Organisation, Governmental Trading Corporation and Trade Promotion Organisation. Meetings were also held with Iran Chamber of Commerce and Rice Importers Association.
- ➤ The deliberations helped to dispel the negative publicity which appeared in some part of Iran media causing doubts about the health and safety of rice from India. Government of Iran may soon issue the notification about resumption of issuance of permits for import of rice.
- ➤ To supplement domestic production of about 2 million MT, Iran imports about 1 million MT of rice every year out of which about 7 lakh MT is exported from India.
