
• Malnutrition was the primary reason behind 69 % of deaths of children below the age of five in India, according to a UNICEF's The State of the World's Children 2019 report.

## A. Health and Wellness Centers (<u>HWCs</u>)

• Deliver Comprehensive Primary Health Care (**CPHC**) bringing healthcare closer to the homes of people.

• Cover both, maternal and child health services and non-communicable diseases, including free essential drugs and diagnostic services.

• In February 2018, the Government of India announced the creation of 1,50,000 Health and Wellness Centres (<u>HWCs</u>) by transforming the existing Sub Centres and Primary Health Centres.



### B. Pradhan Mantri Jan Arogya Yojana (PM-JAY)

- World's largest health insurance/ assurance scheme fully financed by the government.
- Launched on 23rd September, 2018 in Ranchi, Jharkhand.
- Provides a cover of **Rs. 5 lakhs per family** per year for **secondary and tertiary** care hospitalization across **public and private** empanelled hospitals in India.
- Over **10.74 crore poor and vulnerable entitled families** (approximately 50 crore beneficiaries) are eligible for these benefits.
- Provides <u>cashless</u> access to health care services for the beneficiary at the point of service.

• Covers up to 3 days of pre-hospitalization and 15 days post-hospitalization expenses such as diagnostics and medicines.

No restriction on the family size, age or gender.

• Beneficiaries are identified based on the **Socio-Economic Caste Census** (SECC) data in the rural and the urban areas.

National Health Authority (NHA) – implementing agency.


