

### Subhash Chandra Bose Aapda Prabandhan Puraskar

Many organisations and people are quietly but continuously working on disaster mitigation and preparedness in order to reduce the effect of future disasters.

### About Aapda Prabandhan Puraskar

The Government of India has established an annual award to acknowledge outstanding efforts in the field of disaster management by people and institutions in India. Aapda Prabandhan Puraskaar was named after Subhash Chandra Bose.

The administrative responsibilities regarding the award lies with the National Disaster Management Authority (NDMA).

- Up to three prizes will be given out. These prizes are open to both institutions and individuals.
- A certificate and a cash reward of Rs. 51 lakhs will be given to the awardee if it is an institution.
  This cash incentive will only be used for Disaster Management related initiatives by the Institution.
- The winner will get a certificate and a monetary reward of Rs. 5.00 lakhs if the awardee is a person.
- The prize is only open to Indian people and Indian institutions.
- Voluntary associations, business entities, academic/research institutions, response/uniformed units, and any other entity are eligible to apply for institutional awards.
- A contender for this award can be nominated by any Indian national or institution. Selfnomination is also an option for candidates.
- An institution's application does not exclude any individual from that institution from applying for the prize in his or her own right.
- Every year on January 23<sup>rd</sup>, on the birth anniversary of Netaji Subhash Chandra Bose, the winners of the award are announced.



#### Award Criteria

In India, the entrant must have had worked in disaster management related fields such as Research, Innovation, Relief, Rehabilitation, Early Warning, Rescue, Response, Mitigation, Preparedness, and/or Prevention.

The application must include specifics of disaster management activities and must showcase accomplishments in one or more of the following categories:

- 1. Raising public awareness about preparation and risk mitigation.
- 2. Continued operation of critical infrastructure and basic services in the time of catastrophes.
- 3. Recovery and rehabilitation following a calamity.
- 4. In any sector of disaster management, technical/scientific research, and innovations.
- 5. Advanced warning and real-time transmission of disaster risk information to the public.
- 6. Community response and risk mitigation capacity development.
- 7. Initiatives to avoid disasters in hazard prone locations.
- 8. In every aspect of disaster management, innovative and effective utilisation technology.
- 9. Prompt humanitarian operations in disaster stricken areas and communities.
- 10. Mobilisation and allocation of resources for efficient crisis response.
- 11. Lowering the effects of the disasters upon
  - 1. Lives
  - 2. Livestock
  - 3. Livelihoods
  - 4. Property
  - 5. Society
  - 6. Economy
  - 7. Environment
- 12. Saving human lives.
- 13. Any other aspect of disaster risk management.
