

RBI Office Attendant 2022: Eligibility

The Reserve Bank of India invites applications from qualified candidates for the position of Office Attendant at its different offices. This is an excellent chance for anyone interested in working for one of India's most prestigious institutions, the Reserve Bank of India. The official notification for the RBI Office Attendant 2022 is expected to release soon. Before applying online for this position, candidates must read the RBI Office Attendant eligibility details provided in the notification.

Apart from the Office Attendant post, RBI Exams are also conducted for the Grade B Officer, Assistant and other Specialist Officer positions. The exam pattern, selection process, eligibility, etc. of all these posts vary from each other.

RBI Office Attendant 2022- Eligibility Criteria in Detail

The RBI Office Attendant Eligibility 2021 mostly entails the following:

- Nationality
- Age Limit
- Relaxation in Age
- Education Qualification
- Number of Attempts

The given eligibility conditions are based on the notification of 2021, as the official; notification of RBI Office Attendant 2022 is not yet released. The eligibility conditions are discussed in detail in the following section.

RBI Office Attendant 2022: Nationality

Candidates applying for the RBI Office Attendant test must be **Indian citizens**.

The candidate must be a resident of the State/UT that falls within the Regional Jurisdiction of the Recruitment Office to which he or she is applying.

RBI Office Attendant 2022: Age Limit

Candidates must be under the age limit to apply for the RBI Office Attendant position. Candidates must be between the **ages of 18 to 25 years** to apply for the RBI Office Attendant 2022 examination. This indicates that a candidate must have been born between the **dates of 02/02/1997 and 01/02/2004** (both days including). During document verification, candidates will be required to submit documents proving their age to the Recruitment authorities. Candidates who do not meet the RBI Office Attendant age restriction shall be unable to apply for the exam.

RBI Office Attendant 2022: Age Relaxation

For reserved category applicants, there is an age relaxation mandated by the government in RBI Office Attendant recruitment. The age relaxation is shown in the table below.

S.No.	Category	Relaxation
1.	Widows/women judicially separated who are not remarried/divorced women	By 10 years
2.	Scheduled Caste/Scheduled Tribe (SC/ST)	By 5 years, i.e. up to 30 years

3.	Persons with Benchmark Disabilities (PwBD)	By <ul style="list-style-type: none"> • 10 years (GEN/EWS), • 13 years (OBC), • 15 years (SC/ST)
4.	Other Backward Classes (OBC)	By 3 years, i.e. up to 28 years
5.	Ex-Servicemen	To the extent of service rendered by them in the Armed Forces plus an additional period of 3 years subject to a maximum of 50 years.
6.	Candidates having work experience in the Reserve Bank of India	To the extent of the number of years of such experience, subject to a maximum of 3 years.

All caste, physical disability, academic qualification and identification proof documents must be provided when applying online or during verification for the RBI Office Attendant test.

RBI Office Attendant 2022: Educational Qualification

- The candidate must have completed the **10th Standard** (S.S.C./Matriculation) in the State/UT that falls within the Regional Jurisdiction of the Recruiting Office to which he/she is applying. That qualification should be from a State/UT-recognised board.
- Candidates must be undergraduate students. Candidates with higher qualifications, as well as **graduates, are not eligible to apply.**
- Candidates applying to a recruitment office should be fluent in the language of the state/UT they are applying to (read, write, speak, and comprehend the language).
- A candidate in the Ex-servicemen category must have completed the 10th Standard (S.S.C./Matriculation) and served in the armed forces for at least 15 years, provided they have not graduated outside of the Armed Forces.

RBI Office Attendant 2022: Number of Attempts

The RBI Office Attendant has **no such limit on the number of attempts**. Candidates who meet the age requirements (per category) may apply numerous times for this position.

It is to be noted that if the documents or information submitted by the applicants are proven to be null and void or fraudulent at any point, the aspirant's candidature may be cancelled.
