

UPSC EPFO Eligibility

UPSC EPFO Age Relaxation

UPSC EPFO Educational Qualification

An important eligibility criteria for the UPSC EPFO exam is the educational qualification. - Those who have completed an integrated five-year degree in Law or a Master's in Business Administration are eligible to apply for the UPSC EPFO exam.

UPSC EPFO Eligibility - Nationality

UPSC EPFO Nationality refers to the citizenship requirement for appearing in the UPSC EPFO exam. It ensures that only eligible candidates can apply for the exam and compete for the positions. To be eligible for the UPSC EPFO exam, a candidate must be either:



- A citizen of India, or
- A subject of Nepal or Bhutan, or
- An individual of Tibetan origin seeking refuge in India, who arrived prior to January 1, 1962, with the explicit intent of establishing permanent residency in India.
- A person of Indian origin who has migrated from Pakistan, Myanmar, Sri Lanka, and East African countries of Kenya, Uganda, the United Republic of Tanzania, Zambia, Malawi, Zaire, Ethiopia, and Vietnam with the goal of staying in India permanently.

UPSC EPFO Eligibility - Number of Attempts

The official notification for the UPSC EPFO recruitment does not specify any limitations on the number of attempts a candidate can make. As long as the candidates meet the UPSC EPFO Eligibility Criteria and age limits, they can apply for the recruitment through the prescribed format.
