# **TERMS AND CONDITIONS**

## BYJU'S Kick Off - The FIFA World Cup Quiz

BYJU's Kick Off - The FIFA World Cup Quiz ("Quiz") is brought by Think & Learn Private Limited ("BYJU'S" or "Company" or "We" or "Us"). These Terms & Conditions for the Quiz ("Rules") along with the privacy policy (the "Privacy Policy") govern your participation in the Quiz. You agree that, by participating in this Quiz, you will be unconditionally bound by these Rules and you acknowledge and agree that you satisfy all the eligibility requirements for the Quiz, as provided hereinbelow. These Rules are in addition to the terms of use of <a href="https://byjus.com/tnc app/#tncdesc">www.byjus.com</a> (available at <a href="https://byjus.com/tnc app/#privacy policy">https://byjus.com/tnc app/#privacy policy</a>) to which you agree by participating in the Quiz (hereinafter collectively referred to as "Company Terms"). To the extent the Company Terms are inconsistent with the Rules, these Rules will prevail with respect to the Quiz only.

## 1. Eligibility:

- 1.1 The Quiz is open only to any person willing to take part in the Quiz ("**Participant**"), and who, at the time of participating in the Quiz
  - (i) is an Indian citizen; and
  - (ii) is residing in India; and
  - (iii) has:
    - a) not attained the age of 18 (eighteen) years ("**Child Participant**"), then the parents/ legal guardians representing the Child Participant; or
    - b) attained the age of 18 (eighteen) years, then such Participant;
  - (iv) is studying in any school in India from class 4 to class 10 (hereinafter each a "Grade").

(Each such Participant, fulfilling the eligibility criteria provided hereinabove, who has attained the age of 18 years or where applicable, such parents/ legal guardians representing the Child Participant shall hereinafter be referred to as an "Eligible Participant" or "you" or "your").

- 1.2 The participation or winning Rewards (as defined below) in the Quiz does not require purchase of any of the products offered by the Company or any third party.
- 1.3 In the event: (i) the participation of the Eligible Participant in the Quiz is not permitted under applicable law, or (ii) an Eligible Participant has misrepresented, tampered with or attempted to tamper with the Quiz process in any manner, or does not comply with any provisions of these Rules, then in any of such cases Company shall, in addition to being entitled to take appropriate legal action, have the right to disqualify the concerned Eligible Participant at any stage of the Quiz and forfeit any Rewards, if awarded under the Quiz.

## 2. **Details of the Quiz**:

- 2.1. The details regarding this Quiz are available <a href="here">here</a>. Communication regarding this Quiz will also be circulated on Instagram through Company's <a href="Instagram account">Instagram account</a> ("IG Account"). Please note that the Quiz is not sponsored, endorsed, or administered by Instagram or any third party.
- 2.2. The Participants who appear for the Quiz, shall be divided into 2 groups, based on their Grade, as follows:

- Group 1: Grades 4 to 6
- Group 2: Grades 7 to 10

(each group, as abovementioned, shall hereinafter be referred to as a "Group").

- 2.3. The Company shall publish a fully interactive webpage, where the Quiz will be hosted. The Quiz shall comprise of 10 (ten) multiple-choice questions relating to football and the FIFA world cup events (each a "Quiz Question"), set against a timer, for the Participants to attempt. The Quiz for each Group shall have a different set of Quiz Questions, such that the set of 10 Quiz Questions for Group 1 shall be different from the set of 10 Quiz Questions for Group 2. Each such Quiz Question shall have 4 (four) options, out of which, one option shall be the correct answer to such Quiz Question.
- 2.4. The Quiz shall be made available online for the Participants to take part from the time it goes live on Quiz Corner on the BYJU'S Blog on 14<sup>th</sup> December 2022 and closes at 23:59 hours on 22<sup>nd</sup> December 2022 or such other date as per the discretion of the Company ("Quiz Period").
- 2.5. Please note that you can participate in the Quiz only once, which will be considered as a valid entry for the purposes of this Quiz. In case of multiple entries attempted by you for the Quiz, the entry determined by the Company to be the first entry shall be considered as your valid entry for the Quiz.

#### 2.6. <u>Declaration of Winners For The Rewards</u>:

- 2.6.1. Winners will be selected from amongst the participating Eligible Participants. The respective Rewards for all winning Eligible Participants is mentioned as follows.
  - (a) 01 (one) Eligible Participant, from each Group, to get the answers for maximum number of Quiz Questions correct in the shortest time shall be eligible for Al Rihla Competition Football by Adidas and BYJU'S X FIFA Official T-shirt (each reward referred to as "Reward 1"). Accordingly, 04 (four) winners will be chosen from amongst the participating Eligible Participants from each Group, for the Quiz who answer maximum number of Quiz Questions correctly and in the shortest time compared to other Eligible Participants but only after the First Winner from the respective Group (each such Eligible Participant hereinafter referred to as a "Runner-Up").
    - (Reward 1 and Reward 2 shall hereinafter be collectively referred to as "Rewards". The First Winners and the Runners-Up shall hereinafter collectively be referred to as "Winners")
- 2.6.2. BYJU'S will intimate Winners of the Quiz on January 2nd, 2023, via e-mail, short-message service, WhatsApp, and/or telephonic call on the contact details registered with BYJU'S for this Quiz. You will be informed of the mode for receiving the Reward at the time of intimation of Winners of the Quiz.

Accordingly, Company shall have the Rights (but not the obligation) to use the Material in any promotional, marketing and/ or advertising activity, including but not limited to publishing select Material, in whole or part thereof, on its website and other platforms, for any purposes whatsoever.
- 3.4. The Company will select the Winners and sponsor the Rewards, as set out in these Rules. It shall do so based on the criteria mentioned in paragraph 2.6 and its internal criteria and evaluations. By participating in the Quiz, you hereby acknowledge and consent to be contacted by Company for Quiz related communications and for other marketing communications pertaining to Company's products and services through email, Short Message Service or tele-calling on the contact information submitted by you to us for participating is this Quiz.
- 3.7. If for any reason the Quiz is not capable of running as planned or upon occurrence of a force majeure event, the Company reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Quiz.
- 3.8. Company shall be not liable for any delay or adverse effect caused to you as a result of any force majeure circumstances, including without limitation, floods, natural disasters, war, act of terror, political unrests, technical snags, act of God or any circumstance beyond control of Company.

- 3.9. All taxes, levies and duties due and owed under applicable laws in connection with any Rewards, if any, and other related costs shall be borne by you.
