# TERMS AND CONDITIONS OF BYJU'S XCEL – PAPER PLANE CHALLENGE

In order to promote extra-curricular learning and creativity, Think & Learn Private Limited ("BYJU'S") brings to students ("Participants") another fun challenge in the form of 'BYJU'S Xcel – PAPER PLANE CHALLENGE' ("Challenge").

- 1. **Binding Agreement**: In order for an Eligible Participant (*defined below*) to participate in the Challenge:
  - (i) in case such Eligible Participant is below the age of 18 (eighteen) years ("**Child Participant**"), then the parents/ legal guardians representing the Child Participant;
  - (ii) in case the Eligible Participant has attained the age of 18 years, then such Eligible Participant;

(such Eligible Participant who has attained the age of 18 years or where applicable, such parents/ legal guardians representing the Child Participant are referred to as "you" or "your")

must agree to these terms and conditions governing Eligible Participant's participation in the Challenge ("Rules"). Therefore, please read the Rules carefully prior to the Eligible Participant taking part in the Challenge to ensure that you understand and agree with the terms and conditions of the Challenge. You agree that with the Eligible Participant participating in the Challenge, you are unconditionally bound by these Rules.

The participation or winning rewards in the Challenge does not require purchase of any of the products offered by BYJU'S.

2. **Eligibility**: The Challenge is open only to such Participants ("**Eligible Participants**") that (i) are Indian citizens; (ii) are residing in India at the time of participation in the Challenge; (iii) are studying in Class 4 to 10 (both included) in any school in India, at the time of participation in the Challenge; (iii) in case of Child Participants, have obtained your permission to participate in the Challenge and you have unconditionally consented to being bound by these Rules; and (iv) have registered for the 'BYJU'S XCEL – Masterclasses by Eminent Personalities' here ("**Master Class**") and attended the same.

In the event: (i) the participation of the Eligible Participant in the Challenge is not permitted under applicable law, or (ii) you have misrepresented or do not comply with any provisions of these Rules, then in either case BYJU'S shall, in addition to being entitled to take appropriate legal action, have the right to disqualify the concerned Eligible Participant at any stage of the Challenge and forfeit any reward awarded as part of the Challenge.

### 3. **Details of the Challenge**:

3.1. Please note that the Challenge is not sponsored, endorsed, or administered by either FB or IG.

- 3.2. Eligible Participant may participate in the Challenge during the Challenge Period by complying with each of the following requirements: (i) Eligible Participant shall make a paper airplane; (ii) Eligible Participant shall paint the airplane and also give it a name; and (iii) Eligible Participant shall submit a photo of the airplane and its name to <a href="mailto:creativeminds@byjus.com">creativeminds@byjus.com</a>, along with your contact number, Eligible Participant's name and Class, and having the email subject line as 'BYJU'S Xcel Paper Plane Challenge.
- 3.3. The Challenge opens at 00:00 hours on January 23, 2023 and closes at 23:59 hours on January 27, 2023 or such other extended date as decided by BYJU'S in its sole discretion ("Challenge Period").
- 3.4. The entry submitted to participate in the Challenge shall adhere to the requirements, as mentioned in paragraph 3.2 above. Such entry will be evaluated on the merits of the airplane's design and for Eligible Participant's creativity, imagination and innovation in the airplane design sent by you.
- 3.5. Please note that only one entry from you will be accepted as a valid entry for the purposes of this Challenge. In case of multiple entries submitted by you, the entry determined by BYJU'S to be the first entry shall be considered as your valid entry for the Challenge.
- 3.6. The photo, received as part of the entry, which BYJU'S believes to be inappropriate, fraudulent or not complying with the terms of these Rules shall be disqualified.

#### 3.7. Declaration of Winners:

- 3.7.1. The top 01 (one) Eligible Participant from each of the two groups (i.e., Group 1: for Classes 4 to 6; and Group 2: for Classes 7 to 10), evaluated basis the criteria set out in paragraph 3.4 above will have the prospect of being rewarded with a travel voucher worth INR 2,500/- for domestic flights of Indigo airlines in India (each such reward referred to as "Reward 1") and the next top 20 (twenty) Eligible Participants from both the Groups combined, evaluated basis the criteria set out in paragraph 3.4 above will have the prospect of being rewarded with the book titled '100 Paper Planes to Fold and Fly', as available <a href="here">here</a> (each such reward referred to as "Reward 2", whereby Reward 1 and Reward 2 shall hereinafter be collectively referred to as "Rewards"). Please note that you shall have no claim whatsoever against BYJU'S in relation to the selection of winners of the Challenge and BYJU'S shall not have any obligation whatsoever to entertain any query pertaining to the process followed for evaluating and selecting the winners of the Challenge.
- 3.7.3. All intellectual property in the picture submitted as part of the Challenge, for good and valuable consideration set out in these Rules, shall automatically vest in BYJU'S. Accordingly, BYJU'S shall have the right (but not the obligation) to use the picture or any part thereof, Eligible Participant's name and class details submitted as part of the Challenge in any promotional, marketing and/ or advertising activity, including but not limited to publishing select few pictures, in whole or part thereof, on its website and other platforms.
